



## Moksha festival 2019 Vendor Kit

Moksha festival is a celebration of wellness, spiritual expansion and conscious living through: Yoga, Ayurveda, Sacred Music, Energy Medicine, Spiritual Art and Conscious Marketplace. It was organized in the Los Angeles area from 2011 – 2015. We took a break after 2015 and are now reviving it in 2019. Dates for the festival are June 28-30. The venue for the festival is **Mountain Pointe Camp & Conference Center**, located at **11134 Dorothy Ln, Frazier Park, CA 93225**.

Frazier Park is a rustic mountain town in the grapevine mountains, located on the foothills of Frazier mountain and Tecuya mountain. It is far away from the hustle and bustle of city life and yet close enough to drive from Los Angeles. It is about 70 miles north of Los Angeles and the drive to Frazier Park is usually less than 1.5 hours. With four seasons in a year and lot of nature around, it offers a perfect location to relax, rejuvenate and go deeper in our spiritual practice.

Layout of Moksha festival 2019

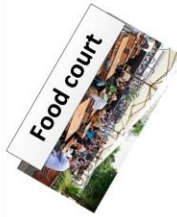
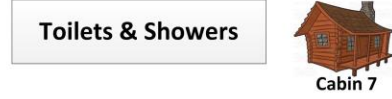

**Moksha Festival 2019, Frazier Park CA - Vendor Agreement**

The following constitutes an agreement between **Yoga Next**, with mailing address PO Box 2290 Frazier Park CA 93225 and [redacted] herein referred to as 'Vendor', located at [redacted].

WHEREAS, Yoga Next is producing an event titled "Moksha, A Festival of Yoga, Sacred Music & Ayurveda" ("Event") to be produced on **June 28<sup>th</sup> – June 30<sup>th</sup>, 2019**, at the venue: **Mountain Pointe Camp & Conference Center** ("Venue"), having its address at **11134 Dorothy Ln, Frazier Park, CA 93225**.

WHEREAS, Vendor is an individual or business according to the terms of this Agreement.

WHEREAS, Yoga Next and Vendor set forth this agreement with the intention of providing a booth space for the Vendor at the Event.

NOW THEREFORE, in consideration of the mutual covenants, representations and warranties set forth herein, the parties hereby agree as follows:

- 1. Yoga Next Provisions** – Yoga Next agrees to provide the following to the Vendor:
  - A. 10ft x 10ft booth at the Event Venue. The Vendor booth space will be located outdoors. Vendor to bring the booth setup up: Canopy, table and chairs.
  - B. Two Weekend Festival Passes for the Vendor. Additional Passes can be purchased at 25% discount.
  - C. Electricity outlet for the booth space, if requested by the Vendor. A fee of **\$100** will be charged for providing electricity.
  - D. Security for the booth from 10.00 PM to 8 AM on June 28<sup>th</sup> and June 29<sup>th</sup>, 2019. Vendors are urged to maintain comprehensive liability insurance and to insure all exhibit and display materials and personal items against theft and damage, as Yoga Next will not be held responsible for any losses due to theft or pilferage during the event.
- 2. Vendor Provisions** - Vendor agrees to provide the following:
  - A. Staff to manage the booths during event hours. Vendor Staff must be 18 years of age or older.
  - B. All Merchandise, Promotional and Display material necessary for Vendor's line of business. All equipment and material belonging to the Vendor must be contained within the 10ft x 10ft booth space.
  - C. Any water, beverages, food, ice. etc for Vendor staff.
  - D. Required licenses and permits to have a booth at the Event. If you are a food vendor you will need a current health or catering permit from the County department of Public Health. The Event management and Venue will not be responsible for any additional permits that may be needed on the Vendor's behalf.
- 3. Fee & Payment for booth space** - Vendor agrees to pay Yoga Next the amount of US \$ [redacted] as rental for the booth space # [redacted]. All checks must be made payable to 'Yoga Next' and mailed to **Yoga Next, PO Box 2290 Frazier Park CA 93225**. Payments may also be made by Paypal, Credit Card or bank transfer to this email address: [yoganext@gmail.com](mailto:yoganext@gmail.com). A surcharge of 3.5% of the payment amount will be applicable for payments made by Paypal or Credit Card. Booth space will be reserved for the Vendor only after receipt of payment for the booth.
- 4. Vendor Move-in/Move-out** – Vendors may start setting up their booths between 8am – 12pm on Friday June 28<sup>th</sup> 2019. Vendors must clean and move out of their spaces by 9.00 PM on June 30<sup>th</sup>. Vendors are liable for all storage and handling charges before opening of the booth or by conclusion of dismantling period. Vehicles will be allowed to load and unload at a designated area at this time. All vehicles must be removed after this time.
- 5. Limitation of Liability** – Vendor assumes entire responsibility and hereby agrees to protect, indemnify, defend and hold harmless Yoga Next, and it's employees, agents or committees harmless against all claims, losses or damages to persons or property, government charges or fines and attorney's fees arising out of or caused by vendor's installation, removal, maintenance, occupancy or use of the premises or a part thereof, excluding any such liability caused by the gross negligence



of the Event, and their employees and agents. Vendor liability includes personal injury caused by vendor’s negligence such as water spills or display breakdowns. Vendors are urged to maintain comprehensive liability insurance and to insure all exhibit and display materials and personal items against theft and damage, as the Event will not be held responsible for any losses due to theft or pilferage during Event hours.

6. **Loss of Income** – Vendor shall not hold Yoga Next responsible for not generating expected income from the Event. Estimated number of attendees at the festival in 2019 is based on previous years’ attendance. Yoga Next cannot guarantee a specific number of attendees at the Event.

7. **Defacing of Property** – Nothing can be attached or fastened to Venue’s walls, floors or columns. Vendors are liable for any damage caused by themselves to the building or damage caused in any other manner.

8. **Soliciting/Samples/Animals** –Samples, catalogs, pamphlets, souvenirs, etc. may be distributed by vendors only from their tables. Violators are subject to expulsion. Vendors may not distribute stickers or decals. Animals are not permitted, unless they support handicapped individuals.

9. **Audio/Visual/Photography** – If audio/visual equipment is used, vendors agree to comply with Venue’s requirements for the operation of the same. In general, all sound devices must be tuned to conversational level and should not be objectionable to neighboring vendors. Yoga Next will make final determination on volumes of audio devices.

10. **Default in Occupancy/Cancellation** – Cancellations received in writing or by email by March 31<sup>st</sup>, 2019 will incur a \$100 cancellation fee. After April 1 2019, cancellations will not be refunded. Any vendors failing to show up and occupy space contracted for is not relieved of the obligation of paying full rental for such space as provided in the signed contract. If not occupied within four hours of Event opening on the first day, Yoga Next may possess such space for purposes as it sees fit.

11. **Vendor Conduct** – Vendors' representatives shall be restricted to owners or employees of exhibiting companies. Vendors shall wear proper badge identification at all times while in the booth. Yoga Next management reserves the right to expel any personnel who are conducting themselves in a discourteous or improper manner in the opinion of Yoga Next. Vendors shall attach no liability to Yoga Next should their personnel be expelled for improper conduct.

12. **Vendor Representatives Responsibility** – Vendor agrees to indemnify Yoga Next and hold harmless for any claims arising from willful or negligent acts of vendors, its agents or employees.

13. **Amendment to Rules** – Any and all matters not specifically covered by these Rules & Regulations shall be subject solely to the decision of Yoga Next. Yoga Next may amend these Rules & Regulations at any time and all amendments so made shall be binding on vendors equally with the foregoing Rules & Regulations.

14. **Agreement to Rules** – Each vendor, for himself and his employees, agrees to abide by the foregoing Rules & Regulations and by any amendments or additions that may be established by Yoga Next.
